

Supporting Local Association Agreement

This agreement is entered into between North American Cycle Sport (“NACS”), a Vermont Limited Liability Company, and _____ (“LA”), a non-profit organization.

The parties agree as follows:

1. The term of this agreement is from the date this agreement is signed by both parties until termination by either party with at least 30 days notice.

LA will:

2. On the LA’s website, acknowledge its support of NACS by prominently displaying the NACS logo along with a link to the NACS website (www.NACS.bike).
3. Consider NACS races for rider category upgrades for road, Cyclocross, track, and mountain bike disciplines, using the long-established rider categorization system which is also used by USA Cycling.
4. Provide input to NACS, as appropriate, on permit applications for events within the LA’s jurisdiction.
5. Include NACS-sanctioned events on the LA’s online event calendar.
6. Assist and provide input to NACS, as appropriate, in the assignment of qualified officials to NACS competitive events.

NACS will:

7. For competitive events, use and follow the long-established rider categorization system which is also used by USA Cycling.
8. On the NACS website, acknowledge the support of LA and provide a link to the LA’s website.
9. Submit all permit applications for events in the LA’s region to the LA for review, input, and calendar coordination and inclusion.
10. Pay remittances on a calendar quarterly basis to the LA based on the following schedule:

Description	NACS Fee	Remit to LA
• NACS Permit (per event)	\$40.00	25% of permit fee = \$10.00
• Non-Competitive Event per rider (e.g., Gravel Grinders, Gran Fondos, charity rides) (includes vehicle insurance)	\$2.10 insurance surcharge + \$0.90 sanctioning fee Total \$3.00	25% of sanctioning fee = \$0.225
• Competitive Off-Road Event per rider (e.g., Mountain Bike endurance events, Cyclocross)	\$3.15 insurance surcharge + \$0.50 sanctioning fee Total \$3.65	25% of sanctioning fee = \$0.125
• Competitive On-Road Event per rider (includes vehicle insurance)	\$3.15 insurance surcharge + \$0.80 sanctioning fee Total \$3.95	25% of sanctioning fee = \$0.20

Note: This schedule will be updated periodically, but the remittance amount as a percentage of the fee will not decrease.

11. **Indemnification.** Each party agrees to indemnify and hold harmless the other, and its agents, officers, directors, representatives, and employees (collectively “representatives”) as to all claims asserted against the other party, and costs (including reasonable attorney fees) and damages incurred by the other party or its representatives, as a result of or arising from the indemnifying party’s or its representatives’ actions or inactions pursuant to this agreement or failure to comply with this agreement.
